his Limited Lifetime Warranty applies, and is provided, only to the original customer/purchaser (hereinafter End User) of the vinyl flooring product, provided to and utilizing FET's Patent pending proprietary manufacturing glued joint technology.

Finished Edge Technology's (FET) Limited Lifetime Warranty does not extend to, nor is it applicable to any subsequent purchaser of the original product, utilizing FETs Patent pending proprietary technology and manufacturing process. This Limited Lifetime Warranty does not extend to, nor is it applicable to any subsequent purchaser of the original product utilizing FETs Patent pending proprietary technology (glued joint manufacturing process).

The Limited Lifetime Warranty does not include, loss of time, inconvenience or incidental expenses related to the replacement of the merchantability in this manufacturing process supplied by FET. affected product. It also does not include, nor cover, any labor or costs associated with the replacement of the affected material, including the cost of the End User provided material.

This Limited Lifetime Warranty only covers the manufacturing process utilized by FET and is limited to the cost of the FET glued joint manufacturing process of creating stair bull noses. The Limited Lifetime Warranty does not include loss of time, inconvenience or incidental expenses, related to the replacement process. It also does not END USER ACKNOWLEDGMENT: FET excludes and End User include nor cover, any labor or costs associated with replacement of the acknowledges and agrees, that FET has no liability for any other affected material, including the original cost of the customer provided material.

This limited lifetime warranty only covers the glued joint manufacturing process, utilized by FET and is limited to the cost of the manufacturing of the FET glued joint manufacturing process of creating, custom stair bull nosing's.

The Limited Lifetime Warranty further, does not cover normal wear and tear of the vinyl utilizing FETs Patent pending proprietary manufacturing technology. This warranty extends to the cost of the glued joint manufacturing process only, it does not cover the cost of the underlying and affected final product (please refer to the vinyl manufacturers warranty for product defects).

WHAT FET'S LIMITED LIFETIME WARRANTY does not cover: Abuse, misuse, neglect, incorrect or negligent installation resulting in gouges, scratches, incorrect or negligent installation of final product after FETs manufactured technologies and product is sold to the End

This Limited Lifetime Warranty does not further apply to damage done to vinyl and FETs glued joint application process, due to damage incurred by moving furniture or the like, up and down the stairs or staircase, which includes use of dollies, carts or moving appliances and of a dispute under this warranty or for any reason. In addition, FETs other heavy objects. Any and all other gross negligence that may be caused by homeowners or renters.

ADDITIONAL WARRANTY EXCLUSIONS: Water damage caused by flooding or any prolonged stay of standing water. Pet urine can erode and destroy materials over time. These types of aforementioned conditions will not be covered.

In the event of a warranty claim, End User agrees to notify FET within 30 days of the defect arising. End User must supply proof of purchase when submitting a warranty claim.

RESOLUTION: The End User's exclusive remedy under FETs Limited Lifetime Warranty is a credit for the actual cost of the glued joint manufacturing process of the End User's vinyl product and nothing additionally. Nothing more is either expressed or implied under this Limited Lifetime Warranty. Further, there is no warranty of

indirect, special, incidental, punitive, exemplary, or consequential damage arising out of or otherwise connected to failure of the glued joint technology or active or passive negligence of FET.

TRANSFERABILITY: This Limited Lifetime Warranty extends only to the original Customer/Purchaser, and End User (defined as original intended owner and End User of the customer supply product with FETs applied technology and manufacturing process).

EFFECTIVE DATE: This Limited Lifetime Warranty begins on the date of delivery to the End User of the manufactured technology.

DISPUTE RESOLUTION: The laws of the State of Arizona are applicable in the event of a dispute involving this warranty between Customer/Purchaser or End User and FET. Customer/purchaser and End User agree that all disputes will be resolved through binding arbitration with and submitted to the American Arbitration Association. In no event will any action be brought in any court of competent jurisdiction in the State of Arizona or any State or Federal Court elsewhere. Customer/purchaser and End User hereby waives their right to a jury trial.

Binding arbitration before the American Arbitration Association is Customer/Purchaser's and End User's only legal remedy in the event liability is limited to the actual cost of the glued joint manufacturing technology of Customer/Purchasers or End User's product.

This warranty is also subject to the following conditions: This product must be installed properly in accordance with the installation instructions and for its intended purpose. Appropriate installation by a qualified professional is highly recommended.
